The Chair welcomed GD and SR to present the findings of the evaluation [see presentation below and evaluation report

circulated with meeting papers]

5.1

- 5.2 GD shared the highlights of the evaluation and gave a brief background to LAC / LCC, further details of which are available in the Evaluation Report.
- 5.3 GD explained that the findings demonstrated the complexities of what coordinators are working with as well as the financial benefits that have been demonstrated, although it was highlighted that each case is unique.
- 5.4 GD emphasised that the focus is on individuals, providing a better life for that individual as well as defining outcomes
- 5.5 By identifying themes, it was possible to identify scenarios and thereby provide a greater understanding of the likely need of the individual and provide better outcomes.
- 5.6 The evaluation has proven that LAC / LCC is developing networks between resources and individuals, therefore building communities, therefore building resilience.
- 5.7 The presentation described the role of the coordinators as the connecting link between all involved. It also highlighted the progression of someone who has received assistance to becoming a person who is able to give assistance, making this a self-sustaining project.
- 5.8 There are 29 recommendations in total, taken from key findings.
- The recommended next steps are to support the work of LAC and LCC, inform key stakeholders of progress, highlight added value as well as inform best practice and address any shortfalls in these initiatives, a continuation of evaluation should be planned collaboratively and applied.
- 5.10 GD and SR invited questions and comments from the Board:
- 5.10.1 MC expressed the wish to see this work expanded across the region. MC also recommended that wherever possible, Board members should try to speak to those involved as they have the knowledge and experience and therefore are best placed to advise on how best to progress. LAC coordinators should be recruited on a 'phased/staged' basis due to the complexity of the role.
- 5.10.2 CT informed the Board that he is promoting informing sessions across the region; responses and engagement have been 'first class' in relation to LAC/ LCC.
- 5.10.3 AD felt that the recommendations should not just be directed at LAs but should also include the HB and that this should be dovetailed with all partners
- 5.10.4 Concerns were expressed around a postcode lottery in terms of the support available as this resource is not available within all communities. GD highlighted that this is a 'local' project with local coordinators; this is more about a tailored response to need.
- 5.10.5 SC explained that the model in Bridgend has only subtle differences to the LAC model but it does follow the overall direction and key principles. BCBC coordinators have surgeries with the HB every week which is proving to be very successful.

- 5.10.6 There was discussion concerning the commitment to Local Community Initiatives (LAC/LCC) going forward across the Western Bay region and to look at a plan to rollout LAC/LCC (timing, resources).
- 5.10.7 SP noted that a dialogue with Welsh Government concerning ICF being a longer term commitment than annual allocations would be appropriate.
- The Board noted the content of the Formative Evaluation Report of Local Community Initiatives in Western Bay produced by Swansea University.

  The Board further agreed that a plan be produced to set out the resources and timings of a potential rollout of LAC/ LCC with full coverage across the region.
- 5.12 The Chair thanked GD and SR for the work undertaken and for an excellent presentation.GD & SR left the meetingHDa joined the meeting

- 6.1 RW provided an update from the February meeting
- 6.1.1 Attendance at the meetings is growing
- 6.1.2 Comments have been received around Population Assessment and changes have been made where appropriate
- 6.1.3 There is a strong feeling among members that there should be more than one representative at the Regional Partnership Board
- 6.1.4 It has been agreed to meet before each Regional Partnership Board in order to discuss the agenda and raise any concerns / issues and provide the opportunity to give their views as the voice of stakeholders
- 6.2 RS confirmed that substitutes are permitted with advance notice
- 6.3 It was agreed that a deputy should be nominated to attend meetings when RW is unable due to other commitments
- 6.5 SH provided an updated from the March meeting
- 6.5.1 The Citizen's Panel is setting up a subgroup to consider a forward work programme
- 6.5.2 Because future Council / Cabinet meetings have not yet been set, it has not been possible to arrange future Regional Partnership Board meetings; this has had a knock on effect and Regional Citizen's Panel meetings cannot be arranged in advance as dates are not known, this is causing frustration among members of the Citizen's Panel.
- 6.6 SH confirmed that Joanne Abbott-Davies also attends Regional Citizen Panel meetings, thereby ensuring a link with ABMU HB, which has been valued by the Panel.
- 6.7 It was agreed to consider the possibility of holding future Regional Partnership Board meetings in public, following discussion concerning transparency; officers to consider the

7.2.1	Better quality services (local authority and health) for vulnerable adults addressing the implications for commissioners of the Winterbourne Review.
7.2.2	Clear and better outcomes for service users
7.2.3	A savings target of £1.3 million across the region for 2014/16, which was achieved by March 2016
7.2.4	A savings target of £1 million across the region for 2016/17, which is on target to be achieved
7.2.5	Better value for money for both local authorities and health services
7.2.6	The development of a robust market that is able to meet current and future needs of people using the services
7.3	DH stated that Appendix A of the report contained details of digital stories/ case studies and the work that has taken place, challenges faced etc
